**ORDER:**

In pursuance of orders issued by Government and Commissioner & Director of School Education, AP Hyderabad in the references cited, the under mentioned **SCHOOL ASSISTANT (BIOLOGICAL SCIENCE)** TELUGU Medium (i) whose posts are shifted and who opted the place are hereby transferred to the post/school (ii) who are transferred to the post school shown against their names as per their willingness/option given during the counseling held on **12/05/2013** as shown in annexure (enclosed).

The concerned Dy.EO's/HM's/M.E.O's are requested to relieve (i) the teachers who are shifted under rationalization from the present place of working as per Rule 5(4) of the GO, on receipt of the transfer order at the first instance (ii) the teacher transferred as per Rule 5 (except sub rule 4) duly taking in to consideration that their shall be 50% of regular teachers (including subject teachers) working in the school as prescribed under Rule 15 of the GO 3<sup>rd</sup> and 5<sup>th</sup> cited, and teacher should join in the new school on the next day of the counseling. Teachers cannot claim compulsory wait under any circumstances for any reason.

Further the concerned Dy.EOs/HMs/MEOs are informed that on account of transfers, no school shall remain without teachers (including subject teachers). In such cases the teacher shall be relieved only after joining of the substitutes.

The orders of the transfer now issued are subject to outcome of SLP of Hon'ble Supreme Court of India and other cases pending.

He/She shall abide by the terms and conditions as stipulated by the Government and are liable for any action deemed fit for violation if any.

The Deputy Education Officer / Head Master / Mandal Educational Officer concerned is instructed to make necessary entries in Service Register of the individual regarding the transfer/date of relief/date of joining and also availment of the special category/preferential category, if utilized.

The dates of relief and joining should be reported promptly.

Receipt of the proceedings should be acknowledged.
