The attention of the Headmasters noted in the annexure appended to this proceedings is invited to the reference 1st cited, where in the Director, RMSA, Andhra Pradesh, Hyderabad issued instructions to arrange to remit back the amounts mentioned in the enclosed statements (at Column No.9) to the RMSA State Office Account and to submit a consolidated compliance report with remittance particulars and also to submit the same through E-mail/ hard copy to State RMSA Office without fail by 31.08.2015. Accordingly in the reference 2nd cited instructions were issued to the concerned Headmasters to remit back the amounts mentioned in the enclosed statement and submit compliance report to this office at once. In spite of repeated reminders out of 19 schools, only two (2) schools Headmasters were submitted the compliance report duly paying the amounts to the Director, RMSA, Andhra Pradesh, Hyderabad. The Director, RMSA, Andhra Pradesh, Hyderabad is repeatedly remaining on the same.

In view of the above, the Headmasters concerned are requested to take immediate steps for remittance of relevant amounts to the State Office Account and submit relevant receipts to this office by 23.09.2015 without fail. Otherwise the defaulters names will be perused to the higher authorities.
