In the reference 9<sup>th</sup> read above, the following instructions were issued in connection with the special pay to the Language Pandits Gr.II for dealing the higher classes in high Schools.

In the reference first read above, the Government sanctioned Special Pays at different rates to various categories of Government employees basing on the recommendations of Pay Revision Commission, 2005. Subsequently based on the recommendation of One Man Committee, 2006 necessary orders were released by the Government in the reference 4<sup>th</sup> read above, duly increasing the rates of special pays in certain cases and sanctioning special pay afresh in some cases w.e.f. 10-08-2006. In the reference 4<sup>th</sup> read above, the Government of Andhra Pradesh have revised the rates of Special Pays in Revised Pay Scales, 2010.

In the reference 5<sup>th</sup> read above, the Commissioner of School Education, A.P., Hyderabad issued specific orders sating that, the special pay is being allowed to the Language Pandits who are having the qualifications to hold the post of School Assistant in particular language, subject condition that, where the sanctioned School Assistant posts are vacant in the High School, such Language Pandits Gr.II are permitted to teach higher classes by allowing special pay of Rs.100/- per month.

Subsequently, the Commissioner of School Education, A.P., Hyderabad in their Proceedings 7<sup>th</sup> read above, instructed all the District Educational Officers in the state to take necessary action for sanction of special Pay to the Language Pandits who are handling IX and X Classes, in accordance with the provisions contained in the Government Order 4<sup>th</sup> read above.

Therefore, all the Headmasters of High Schools in the District are requested to take necessary action and sanction special pay to the Language Pandits working under their jurisdiction immediately in accordance with the provisions contained in the Government Orders and Proceedings of the Commissioner of School Education, A.P., Hyderabad mentioned under reference .

The following amendment is issued in continuation of the proceedings issued in the reference 9<sup>th</sup> read above.
