**Sub: APRMSA –IEDSS** – Student Oriented Activities – Release of Allowances to the CWSN 2016-17- Furnish the required information in prescribed format on or before 25<sup>th</sup> July,2016-Orders issued-Reg.

All the District Educational Officer & District Project Co-ordinators, RMSA and the Project Officers of APSSA in the State are informed that Government of India has approved budget to provide Escort Allowance, Transport Allowance and Stipend for Girls to the Students who are enrolled in Classes 9<sup>th</sup> & 10<sup>th</sup> and attending to the school under the Student Oriented Activities for the year 2016-17.

- i. Escort Allowance is eligible for Children with Cerebral Palsy, Multiple Disabilities and Locomotors disabilities only @ Rs300/-per month for 10 months.
- ii. Transport Allowance is eligible for Children with Blind, Hearing Impairment and Mental Retardation @ Rs300/-per month for 10 months.
- iii. Stipend is eligible for all disability categories of girls enrolled and attending to the school. @ Rs200/-per month for 12 months.

Therefore, it is decided to release the allowances to the CWSN from Head office to the Students' bank accounts directly in every month by informing to the O/o DEOs concerned. The CWSN have minimum of 50% attendance on the working days are eligible to get the above allowances.

Hence, DEOs are requested to get the information from the schools concerned in a prescribed format to make monthly prompt payment of Escort Allowance, Transport Allowance and Stipend for Girls to the eligible students in every month directly to the students' bank account to avoid delay and improve the attendance of the students with disability in schools.

Therefore, all the District Educational Officers are requested to bestow their personal interest and furnish the required information in detail in prescribed format (annexed) and submit the same to the O/o Director, RMSA, AP **on or before 25th July, 2016 in soft & hard copies** so as to take necessary action to release the allowances to the Children with Special Needs.
