ORDER:

Under rule 10 (a) of A.P. State & Subordinate Service rules 1996, read with the orders / instructions issued in the reference cited, the teachers of Class I mentioned in the annexure are hereby promoted to the post of Headmaster Grade-II (Gazetted) in Zilla Parishad High Schools and posted against the vacancy noted against their names as per their willingness given during the counselling held on 24.01.2017.

The above promotion is purely temporary basis subject to review at future date and outcome of pending court cases and also liable for termination at any time without notice and without assigning any reason thereof for such termination.

They are not entitled for TTA and joining time as the postings are ordered as per their choice.

They are requested to join immediately on relief in the new promotion post within 15 days from the date of receipt of these orders failing which they will forfeit their right for promotion in the present and in the future as per G.O.Ms.No.193 GAD dated:23.04.1999 and submit their joining report to the Deputy Educational Officer/District Educational Officer concerned.

The concerned HM is requested to relieve the teachers mentioned in the Annexure immediately with instructions to join at their new station without fail.

The promotion orders now issued are subject to the condition that his / her seniority is subject to the outcome of the SLP No.22597/612/2004 and 8874/2007 pending in the Hon'ble Supreme Court of India, New Delhi on unified teachers service rules.

The dates of relief and joining shall be reported promptly.
