Identification of Pvt Management Schools to adopt children for Sports training under LTAD programme

The Government of AP with a vision to develop the Sports culture that celebrates and promotes participation and excellence in Sports training for all citizens of AP. It proposes by using holistic approaches like **Long Term Athletic Development Programme** to increase exposure to Sports; to improve physical and mental health of children and youth.

OBJECTIVES:

The main objective of the Scheme is to make use of the good infrastructure of Academic as well as Sports training available in the Private Management Schools to train the children in the age group of 8 to 15 years of age for the future medal hopes by providing scientific training under LTAD Programme.

Under the Scheme Schools having good Sports infrastructure are adopted by SAAP to enable the budding Sports persons to study and play in the same School.

The Private Management Schools willing to adopt the Sports Children has to take the responsibility of providing.

1. Boarding/Lodging
2. Educational expenses
3. Playfield maintenance
4. Medical etc.,

The SAAP will be provide assistance to the selected children through School Management is as follows.

1. Sports equipment
2. Sports kit
3. Coaches /Sports Trainers
4. Competition exposure
5. Insurance

Selection Criteria:

- Selection of children under the above scheme is done basing on the physical abilities /motor quality tests and performance base.
 - The players/Children who are Medal winners in State/ National level competitions will be called for residential Coaching camps to assess the performance and will be admitted after Medical & Age verification.
 - Players who are Medal winners at District level Competitions will be called for residential training programme and will be admitted based on their performance after Medical & age verification.
 - For the selection of raw talent from the remote, tribal & Coastal areas competitions are organised for both Team & Individual Sports to identify the talented children.
- The selection will be done by a committee nominated by the Government 1) Age verification between 8 to 14 years
- 2) Application of battery of test on children to assess the physical efficiency of the Children
- 3) Application of Specific games/Skill tests.
- 4) Medical examination of the children those who qualified in the above tests.
- The each selected Sports discipline about 30 students shall be there under Long Term Athletic Development .
- **Benefits to Schools**
 - Funds for recruiting 3 to 4 Coaches for conducting in School training programme
 - 3 to 4 Coaches for excellence training recruited by SAAP will be provided to School.
 - Excellence Coaches to be hired by SAAP.
 - Equipement for 4 to 5 Sports Disciplines to be provided by SAAP.
 - Annual maintenance cost for equipment to be provided by SAAP.
 - Sports team comprising Sports School Students representing the School will be funded for travel and tournament exposure by SAAP.
 - Name and fame shall come to school through Sports achievements of its students.
