The Government in the ref 1<sup>st</sup> to 4<sup>th</sup> read above have issued rules for Transfer of the Gazetted Headmasters / Teachers working in Government /ZPP/MPP schools in Andhra Pradesh school Education ,Service and Andhra Pradesh School Education subordinate service. Accordingly, the applications are invited from the teacher and counseling was conducted to the teachers who are under (a) compulsory transfer (8 academic years of stay), (b) effected under Rationalization (c) Request Transfers.

In the ref 5<sup>th</sup> read above instructions were issued by the Commissioner of School Education, A.P., Amaravathi to take up the work adjustment of surplus teachers who are under DEO's Pool to the needy schools.

As the teachers mentioned in the annexure found surplus and releived on the AN of 18-08-2017 were instructed to report before the concerned Mandal Educational officers until the alternate arrangements were made for them.

Accordingly the matter was placed before the Transfer counseling 2017 committee to accommodate them against the School Assistant (Maths) posts, against School Assistant (Social) posts until they were absorbed in their regular line. The committee has approved the same

Accordingly, work adjustment counseling was conducted on 08-09-2017 to those candidates who were under DEO Pool and as per their options orders were issued ( Annexure appended) to join against the SA (Maths) and Clear vacancies of SA (PS) and , SA(Social) vacancies.

Further it is here by informed that this is purely temperedly work adjustment of candidates for instructions to students and until further orders are issued and it will not confer any right to the candidates on the place of vacancy.

The teachers now adjusted under work adjustment as per the options exercised by them are informed that, if the need of their service is not justifiable at the adjusted schools for any valid reasons, their services will be utilized in another needy schools to ensure class level teacher -pupil ratio and also for strengthening academic monitoring tin those schools.

Salaries to the teachers deployed under work adjustment shall be paid from the schools where they are adjusted. If no vacancies—is available in the school, salaries of such teacher may be drawn from the available vacancy in the District. Further the teachers mentioned in the annexure who were reported before the concerned Mandal Education all officers shall be paid salaries from the post shown against their names from the date of original relief from his original post duly obtaining the attendance certificate from the Mandal Educational officer concerned i.e 19-08-2017.

The Deputy Director O/o District Treasury Nellore / Asst Treasury offices concerned / sub Treasury offices Concerned in the district are requested to honor the playbills of the teachers mentioned in the annexure to avoid any hard ship to the teachers.

These orders are issued subject to outcome of SLP in the Hon'ble Supreme Court of India and pending cases.

The teachers who are not posted under work adjustment are not entitled for TTA and Joining time as the transfers are made at their requests and as per the rules and procedure issued in the above Government orders.

The above order shall be implemented without any deviations .
