The attention of all the District Educational Officers / RJDSEs in
the State is invited to the reference 1st read above and they are informed that
No. of DEOs are requesting clarifications for constituting / Nominating of
Members in High School level Committees (SMDC) and for Opening of Bank
Accounts relating to " Rashtriya Madhyamik Shiksha Abhiyan"(R.M.S.A) scheme.

The guidelines for selection of SMDC members at High School Level is as
follows:

1. HM / Principal of the Secondary School/ Hr. Secondary School;
chairman of the Committee.
2. Sr. most School Assistant: Vice-Principal member
3. One teacher related to Social Science, Sr. most teacher in Social
Science
4. One teacher related to Science , Member; Sr. most teachers in Bio
Science/ Physical Science
5. One teacher related to Mathematics, Sr. most teacher in
Mathematics
6. One gentleman from parents (Father/Mother of the child of
highest class in the school who secured highest marks in the last
annual examination)
7. Two members from gram panchayat or Urban local body who are
parent of the children (the HM has to make a written request to
nominate 2 members from the gram panchayat / Urban Local
body to the Secretary, Panchayat/ Municipal Commissioner).
8. One member from SC/ST Community: (The parent of SC/ST child
of highest class in the school who secured highest marks).
9. One member from Educationally Backward Minority (Parent of the
child belonging to Educationally Backward Minority who secured
highest marks in the annual exams of the highest class in the
school).
10. One member from Education Development Committee of each
village. (Instructions will be given as soon as the SMDC is formed).
11. Three expert members from Science, Humanities and
Art/Craft/Culture/Sports (District IASEs / DIET faculty).
12. One officer from Education department (MEO concerned).
13. One member from Audits Accts department (Auditor of the Local
Fund allotted to the school).

Sub-Committees:

School Building Committee:

- HM ; Chairman
- One member from Panchayat nominated by the Sarpanch - (whose child is studying in the school).
- One member from parents (the parent at Sl.No.6)
- One member expert in civil work nominated by the Dy.E.E, executing agency of construction of that building.
- One member from Local Fund Audit (the member at Sl.No.13).

Academic Committee:

- Senior most School Assistant / Vice Principal - Chairman
- One member from parents - whose child is studying in the school - (selected at Sl.No.6)
- Members from experts, each from Science, Mathematics, Humanities, Art/Craft/Culture/Sports etc (members selected at Sl.No.11) - DIETs/IASEs.
- One student selected by the Head Master/Principal (option of Head Master/Principal).

Regarding Opening of Bank accounts:

- For opening of RMSA Bank Accounts at High School Level the accounts should be opened at SBI Branches only and where ever SBI Branches are not available they are permitted to open Bank Accounts only in Government Nationalized Banks nearest to the school because all the funds will be transferred up to school level through ECS facility as per the norms of GOI for implementation of the RMSA Scheme in the State.
- For opening of Bank Accounts all the Head Masters of High Schools in the State will be provided an amount of Rs.500/- for each school from the preparatory activities budget to be released by this office The Joint Acct. should be opened in name and style as follows "The Head Master & Chairman SMDC, Z.P.S.S....., District and Senior most School Assistant, Z.P.S.S...."

Therefore all the DEOs and RJDEs are requested to take necessary action at once.
