In partial modification of orders in the reference 12 cited, the following orders are issued.

In the reference 5th cited, previously orders were issued to the DEO Pool teachers and stated that as follows " It is informed that, this is purely temporary work adjustment of candidates for instructions to students until further orders are issued and it will not confer any right to the candidates on the place of vacancy. The teachers now adjusted under work Adjustment as per the options exercised by them are informed that, if the need of their service is not justifiable at the adjusted schools for any valid reasons, their services will be utilized in another needy schools to ensure class level teacher-pupil ratio and also for strengthening academic monitoring in those schools."

In the reference 6th cited above, The Commissioner of School Education, Amaravathi has issued orders to conduct the counselling for DEO Pool, work adjustment teachers in promotion vacancies duly following the guidelines.

Accordingly, 97 Secondary Grade Teachers who are working in the DEO Pool due to rationalisation of posts in 2017 are allotted to the permanent places by conducting counselling to the opted places.

16 DEO Pool Secondary Grade Teachers have submitted their willing ness to continue in the same places at the time of counselling on 13-08-2019. Hence, in the reference 10th cited, clarification is sought from the Regional Joint Director of School Education, Guntur. In the reference 11th cited, the Regional Joint Director of School Education, Guntur has issued certain clarification on the DEO Pool teachers who are willing to continue in the same places.

At Present District Educational Officer, S.P.S.R Nellore is pleased to accord permission to the 16 DEO Pool Secondary Grade Teachers to permanently continue in the same places at where they are getting salaries.

Therefore, the Mandal Educational Officer concerned are requested to take necessary take action as per rules.
