The Commissioner and Director of School Education, A. P, Hyderabad had issued instructions vide Pro.Rc.No.1379/D1-3/2010-2, dated:09.04.2010 on the verification of fake certificates produced by certain teachers during the promotion counselling held in Feb 2009. Accordingly, 86 teachers were identified in the District.

Later the Commissioner and Director of School Education, A. P, Hyderabad had issued instructions in Pro.Rc.No.478/D1-2/2013, dated:22.02.2013 stating that the matter was referred to the CBCID department. A detailed report was submitted by this office to the additional Director General of Police, CID, A.P. Hyderabad while Lr.Rc.No.487/A5(A3)/2010, dated:12.06.2013. Meanwhile certain teachers have approached the Hon'ble APAT in this matter.

Later the Deputy Superintendent of Police crime investigation department, Regional office, Nellore has sent report on in the year 2015 stating that the 58 teachers out of 87 certificates are Genuine but they studied the course without the prior permission from the department and requested to take departmental action as per CCA rules.

On 18.05.2009 the Director of School Education, A. P, Hyderabad had issued instructions in Proc.Rc.No.09/D1/D2/(PTC)/2009 as follows. **It has been further reported that in most the cases they did not apply for any permission from the higher authorities to prosecute further studies, as it is through distance mode. But they have produced all other supporting documents. Hence, they requested that their certificates may not be treated as invalid solely on the ground that they did not obtain prior permission. The request is considered, and the District Educational Officers are directed to consider only such certificates valid if all other supporting documents are produced and verified.**

Meanwhile the Commissioner and Director of School Education, A. P, Hyderabad had issued instructions while Proc.Rc.No.478/Estt-III (D1- 2)/2013, dated:26.06.2016 instructing the District Educational Officer, SPSR Nellore to take action against the said teachers as follows. "In view of the above circumstance the District Educational Officer, Nellore is hereby instructed to initiate disciplinary action against above said 54 teachers'under CCA Rules and furnish action taken report directly to Additional Director of General of Police, Crime Investigation Department, Andhra Pradesh, Hyderabad under intimation to this Office."

As per the instructions of the Commissioner and Director of School Education, A. P, Hyderabad in Proc.Rc.No.478/Estt-III (D1-2)/2013, dated:26.06.2016 54 teachers were awarded Minor punishment of "CENSURE".

After that the said teachers had represented the Commissioner of School Education, A.P, Amaravati in this matter to with draw the orders issued by this office of "CENSURE" along with notional seniority. In turn the Commissioner of School Education, A. P, Amaravati had issued instructions to submit a report in this matter and the same was placed before the Commissioner of School Education, A.P, Amaravati. In turn the Commissioner of School Education, A.P, Amaravati had issued instructions vide Proc.Rc.No.2202/Estt.IV/2018, dated:22.03.2019 duly with drawing the punishment awarded by this office i.e., CENSURE with a warning.

As the Commissioner of School Education, A.P, Amaravati has withdrawn the award of Minor punishment with a warning the 54 teachers mentioned in the annexure are here by awarded notional seniority with effect from 02.02.2009 i.e., from the date of joining of on par with the teachers who were promoted in the 2009 promotion counselling i.e., 02.02.2009.

Further, the teachers mentioned in the annexure are here by informed that the seniority now accorded is purely notional and monitory benefit shall not be allowed.
