ORDER:

The Director of School Education, AP., has issued guidelines to take up promotions upto the cadre of Headmasters and School Assistants & Equivalent cadres vide reference 1st read above. Accordingly, willingness was obtained from the eligible teachers and the concerned individuals have submitted their willingness for promotion in the reference 2nd read above.

After completion of the above process the individuals have exercised their options through web counseling. Promotion orders have been issued vide reference 6th read above.

Further, the Director of School Education, AP as issued guidelines to be followed with regard to Adhoc promotions issued as School Assistant & equivalent cadres and Headmasters vide reference 3rd and 4th read above due to Court cases.

Hence, the teachers who got Adhoc promotion as Headmaster are hereby posted temporarily in existing vacancy mentioned against their names in Annexure for drawal of salary only.

Further they are informed that these postings are purely adhoc basis with effect from 14-01-2021 for the purpose of drawing their salary only, from the date of promotion and they have to exercise their options for place of posing through web counseling as per the revised schedule communicated by the Director of School Education, AP vide reference 5th read above. Their transfers and place of posting will be issued as per web counseling to be taken up in compliance to the directions issued by Hon'ble AP High Court in W.P.No.21482/2020, W.P.No. 20944 of 2020/WPNo.22683 of 2020.

The promotion orders now issued are subject to the following conditions.

- That their seniority is subject to the outcome of Judgments pending before the Hon'ble High Court, AP / Supreme Court of India if any.
- That they shall abide by the terms and conditions stipulated by the Government and they are liable for any disciplinary action deemed fit for violation there of if any.

The above promotions are purely temporarily and they are liable for reversion at any time without any notice and without assigning any reason there of for such reversion.




