The Erstwhile District Educational Officers of Guntur, Prakasam and SPSR Nellore and Deputy Educational Officers concerned are further informed that they will be held personally responsible for irregular sanction of pension on behalf of those incumbents without recovery of dues pending and pending charges, if any. The District Educational Officers and Deputy Educational Officers in the zone are requested to take necessary further action in the matter.


