ORDER:

The Government transferred the supervision and administrative responsibilities of Municipal Schools, including service matters of the Municipal Teachers, to the School Education Department on par with the system being followed in the respect of Government and Panchayat Raj Schools. Following this, the Government adopted the Municipal Teachers Service Rules and issued amendments to them on par with Government and Panchayat Raj Headmasters / Teachers Service Rules.

As such, guidelines have been issued by the Director of School Education, A.P., Amaravati to all District Educational Officers in the state to take up promotions from the feeder category of Secondary Grade Teacher and equivalent cadres to the vacant posts of School Assistants on adhoc basis vide reference 3rd read above.

Accordingly, the teachers who are eligible for promotion to the post of the School Assistants attended the counselling and exercised their option for place of posting.

After carefully examining their eligibility, the Secondary Grade Teachers and equivalent cadres shown in the annexure are hereby promoted to the post of Schools Assistants under Rule 10 (a) of A.P. State and Sub-ordinate Service Rules 1996, read with various orders /instructions issued for promotions in Municipal Corporation, Nellore, on purely adhoc basis and posted to the places shown against their names.

The above promotions are purely temporary and are liable for reversion at any time without any notice and without assigning any reason thereof for such reversion.

The promotion orders now issued are subject to the following conditions:

- Promotion is subject to the outcome of the judgments pending before the Hon'ble High Court/ Supreme Court of India if any.
- Individuals Promoted shall abide by the terms and conditions stipulated by the Government and they are liable for any disciplinary action deemed fit for violation thereof if any.

They are informed to join in the new promotion post within (15) days failing which they will forfeit their right for promotion in the present and in the future as per G.O.Ms.No.193 GAD 23.04.1999.

They are not entitled for TTA and joining time as the postings are ordered as per their request.

In order to ensure smooth functioning of School, the teachers now promoted are here by directed to report in the new station and thereby relieved immediately in the new school to work in the previous station on OD basis till last working day of school.

The Heads of institutions concerned are requested to implement the instructions as mentioned above.
